QAGOMA will provide this information to Queensland Health if requested. Your information will be stored securely, not used for any other purpose and destroyed after 56 days or as advised by QHealth.

- Groups must adhere to social distancing requirements and remain 1.5m apart from other Gallery visitors at all times.
- Groups must split into smaller groups of 5–6 people when moving through gallery spaces. Please ensure there is an adequate adult to student supervision ratio.

To comply with COVID-SAFE measures:

- At peak times, booked groups may need to queue for exhibition entry and may be asked to enter as small groups rather than as a complete group
- At peak times, capacity restrictions may prevent groups from entering the exhibition at their specific booking time
- Where possible, groups are encouraged to refrain from bringing school bags
